Introduction : The phenomenon of illegal immigration is one of the most prominent problems facing countries of the world, given the accompanying secretions and security, economic and social problems that may negatively affect the security, development and stability of future and exporting countries of migrants, as well as countries of transit. Libya, as one of the Mediterranean countries, has suffered from security and political chaos since 2011, and from a political and institutional division that has made it a fertile environment for illegal armed groups and human trafficking networks. Illegal immigration in general and to Europe via Libya specifically , in addition to identifying the efforts of local , regional and international leaders in addressing this phenomenon , and proposing solutions and

proposals to be reached from a scientific and practical perspective to address this phenomenon and determine the mechanisms to deal with it and mitigate its effects And its burdens on the Libyan society .

Fourth: the economic axis:

- The increase in corruption and the inflation of the informal economy and their relationship to illegal immigration in Libya.

Fifth: the social axis:

- The social and psychological effects of illegal immigration.
- The role of civil society institutions and international organizations in issues of illegal immigration.
- The mental image in the Libyan society of illegal immigration.
- Illegal immigration and its impact on demographic change in Libya.

Conditions for participation:

- Adherence to scientific research methods in preparing research papers in terms of marginalization, writing references and language integrity.
- The research paper does not exceed 20 papers.
- Close association with the conference theme.
- That the research has n't been presented in a previous seminar or conference, or been published in a scientific journal.

The research cover page should include the following elements:

Research title / name of the researcher / workplace of the researcher / mobile phone number / e-mail / and a CV must be attached to the research to identify the researcher.

- The deadline for receiving research papers after the final amendment is 11/15/2020.
